The unpredictability of an equine's reaction to sounds, sudden movements, unfamiliar objects, individuals or other animals.

An equine's reaction to certain natural hazards, such as surface and subsurface ground conditions.

A collision with other equines or objects.

An equine's response to the participant's manner of handling or controlling it or inability to handle or control it.
